

CANTONMENT BOARD DALHOUSIE CANTT DISTT CHAMBA (HP)

PUBLIC NOTICE

It is hereby notified for the information of the general public that Cantonment Board, Dalhousie Cantt has decided to give on license the collection of Toll Tax, levied under section 60 of Cantonments Act, 1924 (now section 66 of Cantonments Act 2006), within the limits of the Dalhousie Cantonment (toll barrier situated at Banikhet), by the Govt. of India, Ministry of Defence, New Delhi vide their Notification No. 1684 dated, 01-10-1949 as amended from time to time, for a period of one year commencing from **01-04-2016** to **31-03-2017**.

E-Tenders are invited through electronic tendering system for the collection of Toll Tax situated at Banikhet from interested parties/contractors who are technically and financially capable as per the terms and conditions given below.

- All the details mentioned or documents attached, must be legible and clear. Ambiguous/unclear documents will not be accepted, and the bid is liable to be rejected.

TERMS AND CONDITIONS

1. The tender documents can be downloaded from the website **www.cbdalhousie.org** and **<http://eprocure.gov.in/eprocure/app>**. All the critical dates regarding the tender have been given in one of the sections below
2. The tender fees of Rs.1000/- (not refundable) must be deposited as per the details are given below:

The statement of transaction must be attached along with other Technical Bid documents.

3. The EMD of Rs.5,00,000/- must be attached along with other Technical Bid documents. The EMD must be in the form of FDR, of not less than 1 year, of any Nationalized Bank duly pledged in favor of Chief Executive Officer, Dalhousie Cantt.
4. The successful bidder will have to deposit 25% of the highest bid as security, in advance, in the form of the FDR of any Nationalized Bank duly pledged in favour of Chief Executive Officer, Dalhousie Cantt, immediately after acceptance of the bid. This FDR will be released to the bidder after one month on the completion of the contract period i.e one month after 31-03-2017. The Cantonment Board, Dalhousie Cantt, reserves the right to accept or reject any bid at any time without assigning any reason or written notice.
5. The successful Bidder will have to abide by all the provisions of the Cantonments Act, 2006 or any other instructions of the Govt. of India or Chief Executive Officer.
6. The Chief Executive Officer or any person authorized by him may inspect the Toll Post at any time.
7. The successful bidder will execute an agreement with the Cantonment Board, Dalhousie Cantt, on non judicial stamp paper of Rs 20/- within 7 days of the acceptance letter and before taking over the charge of the Toll Post, failing which earnest money Rs 5,00,000/- deposited by him will be forfeited by the Board.
8. The amount offered by the successful bidder will be deposited in advance in 04 equal quarterly installments on or before 10th of first month of the quarter i.e. 01-04-2016, 10-07-2016, 10-10-2016 and 10-01-2017, failing which, 18% penal interest will be charged. In the event of non-payment of quarterly installment by the end of the month, the contract is liable to be terminated immediately without

any notice at the risk and cost of the successful bidder apart from forfeiture of security. The installment will be received of full amount. No part payment of quarterly installment will be accepted.

9. All Toll Tax receipt books will be got printed by the successful bidder at his own expense & will be verified by the undersigned before use.
10. Although the Toll Post will be given on license for a period of one year yet in case of any administrative difficulty for any delay in handing over the Toll Post, bid amount will be adjusted proportionately on average basis of each day.
11. The premises of the Toll Post shall not be used for any other purpose except for the recovery of the Toll Tax. No unwanted person will be allowed to sit/stay at the Toll Tax Barrier.
12. The licensee shall engage educated and well-behaved staff showing due courtesy and respect to the public, for running Toll Tax Post. The complete bio –data of the staff working in the Toll Post will be provided by the license to the Cantonment Board. All pay & allowances of the staff engaged by the license will be borne by him only. The character and other antecedents of the staff of Toll Tax will be got verified from the Police by the licensee.
13. The licensee will be responsible to implement all Labour laws i.e. by the Minimum Wages Act, Labour Act, payment of Compensation Act or any other Act in force for this purpose.
14. The licensee will be solely responsible for any illegal and anti-social activities in the premises. The license will be liable to pay the compensation for any damage to the premises.
15. The successful bidder shall be responsible for adopting all precautionary measures with due care and safety, at the time of stopping the vehicle for the payment of Toll Tax.
16. Conditional bids will not be considered/entertained/accepted.
17. The Toll Tax post will remain open round the clock.
18. On the expiry of the contract period or in case of termination of license period, the licensee shall hand over the possession of the vacant premises peacefully to the Cantonment Board.
19. The Cantonment Board shall not be responsible for any loss/disruption sustained by the contractor due to strike, natural calamities or due to any other reason.
20. No subletting or partnership will be permitted.

21. Toll Tax is not levied on Union/State Government vehicles, Army vehicles, Cantonment Board vehicles, Municipal Committee vehicles or any other category specified by Govt. order.
22. The contractor will be liable to pay the charges of electricity and telephone bills etc.
23. Presently the Toll Tax Barrier is functioning from the post near NHPC Chowk. In case the licensee uses the retiring room, he will have to pay Rs.1000/- per month as rent to the Board. The licensee can be permitted to shift the location of the Toll Tax Barrier to any other place, but he will have to raise temporary structure (with wood and CGI sheets) at his own expense at the new site.
24. The Toll Tax will be levied on the vehicles coming from Nainikhad side only.
25. It will be the responsibility of the license to obtain Cantt 4-B receipt of the deposited amount from the Tax clerk of Cantonment Board, failing which; Cantonment Board will not be responsible for any lapse/loss.
26. If the License fails to collect the Toll due to one reason or the other, the Cantonment Board will not be responsible for any loss etc.
27. In case the recovery of any amount remains in balance from the licensee, it will be recovered from him under section 324 of the Cantonments Act 2006.
28. The Cantonment Board will be competent to modify or add any condition in the Agreement.
29. The official reserve bid will Rs. **40,00,000/-** any bid less than this amount will not be considered/accepted.
30. All the bidders are required to clear their due, if any, of taxes payable to Cantonment Board.
31. The vehicles going for filling of petrol/ diesel to petrol pump near Toll Tax Barrier will not be liable to pay the Toll Tax.

32. The Toll Tax rates are as follows :

| S.No. | Description of vehicle | Rates of Toll Tax/vehicle. |
|-------|--------------------------------------|----------------------------|
| 1 | Pvt Car, jeep, Sumo ,Qualis etc | Rs.10/- per vehicle |
| 2 | Taxies, NC ,Pick up etc | Rs.20/- per vehicle |
| 3 | Tempo Traveller/Mini bus | Rs.30/- per vehicle |
| 4 | Bus, Truck etc | Rs.40/- per vehicle |
| 5 | Big Trolley | Rs.50/- per vehicle |
| 6 | Private car/jeep etc (annual pass) | Rs.250/- per vehicle |

33. In case of any dispute relating to any terms and conditions or other matter relating to the Toll Tax or its collection, the matter will be referred to the President Cantonment Board, Dalhousie Cantt, for arbitration whose decision will be final and binding on all parties.
34. Any bid once offered cannot be cancelled or amended in any manner by the bidders. In such case earnest money of Rs. **5,00,000/-** will be forfeited by the Cantonment Board.
35. If the amount of the bid found equal of two or more bidders, the lottery system will be adopted.
36. The Toll Tax receipt will be valid for 12 hours only for private car etc and school buses carrying students.
37. **No manual bids will be accepted.** All bids must be submitted online using www.eprocure.gov.in website.
38. The Cantonment Board reserves the right to change the terms and conditions at any time. The same will be updated on the above mentioned websites.
