Incomplete applications or application received without any of the enclosures shall be rejected.
3. Attached self attested copies of date of birth, educational certificate, SC/ST/OBC(Non creamy layer) certificate, One self addressed envelopes of size(5'x11") with postal stamp

of Rs.40/-, Two recent passport size color photographs of candidate (with clear quality, one pasted on application & one attached with application) and original Demand Draft/ Indian Postal Order along with duly filled application.

4. Application fee **Rs.300/-** drawn in the favour of **Chief Executive Officer, Bakloh Cantonment** payable at [ **PNB –BAKLOH, OR SBI-KAKIRA, Branch /IPO payable at Sub-Post Office-Bakloh**. The name of candidate with address should be mentioned at the back of demand draft with blue/ black ink. The fee is non-refundable / non-adjustable. **SC/ST Categories need not send DD/IPO but should submit self attested copy of SC/ST certificate in support**. Demand Draft/ Postal order of rejected applications will not be refunded.

## RECRUITMENT PROCEDURE

1. **CANDIDATES TO ENSURE THEIR ELIGIBILITY FOR THE EXAMINATION:**

The Candidates applying for the examination should ensure that they fulfill all eligibility conditions for admission to examination. Their admission to all the stages of the examination will be purely **provisional** subject to satisfying the prescribed eligibility conditions. Mere issue of Admit Card to the candidate will not imply that his/her candidature has been finally cleared by the Cantonment Board, Bakloh. **Candidates are advised to bring their original certificates and hall ticket at the time of written/Skill test.**

2. **SELECTION PROCEDURE:-**

Selection will be made on the basis of screening /skill test conducted by Appointing Authority of Cantonment Board, Bakloh. Qualifying passing marks for screening test will be 45 marks. **Candidates who obtained qualifying passing marks in Screening(written) test will be allow for skill test only.** Candidate having typewriting speed on computer both Hindi and English is less than 25 words per minute/ 30 words per minute will not be consider for selection.
